ASSUMPTION OF RISKS- SPORTS INJURIES, ICE HAZARDS, EQUIPMENT FAILURES, ETC.

ASSUMPTION OF RISKS - COVID-19

Although preventative measures set forth by the Releasees are intended to help reduce the spread of COVID-19, the Releasees cannot guarantee that I will not be exposed while participating in the SaskTel Centre Hockey League. I acknowledge the contagious nature of COVID-19 and accept all risks related to this virus and and potential outbreak or transmission of infections resulting from participation and I agree to release, waive and discharge the Releasees, liable for any resulting illness or injury arising from your visit and/or use of the facility. I also acknowledge notice of and agree to follow all facility rules, posted instructions, and protocols to the best of my abilities.

I AM AWARE OF THE RISK, DANGERS AND HAZARDS ASSOCIATED WITH THE SPORT OF HOCKEY AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees allowing me to participate in the sport of hockey under the auspices of the SaskTel Centre Hockey League (SCHL), and for good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense, illness or injury including death that I may suffer, or that my next of kin may suffer as a result of my participation in hockey. DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER OCCUPIERS' LIABILITY ON THE PART OF THE RELEASEES, AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF HOCKEY REFERRED TO ABOVE;
- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage of, or personal injury to, any third party as a result of any aspect of my participation in hockey;
- 3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
- 4. This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Saskatchewan and no other jurisdiction; and
- 5. Any litigation involving the parties to this Agreement shall be brought solely within the Province of Saskatchewan and shall be within the exclusive jurisdiction of the Courts of the Province of Saskatchewan.

I CONFIRM THAT I HAVE READ AND UNDERSTAND THIS AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I MAY HAVE AGAINST THE RELEASEES.
